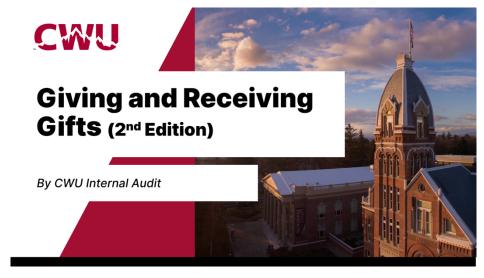

#### **Best Practices**

#### **Procurement Cards**

University Procurement Cards are used at many centralized locations for a variety of purchases. Best practices for cardholders include:

- 1. Retaining itemize receipts for allowable purchases.
- 2. Obtaining pre-approvals when required.
- 3. Gathering and assembling all supporting documentation.

The Office of Financial Management (OFM) and University policies and procedures prescribes the guidance for usage and documentation of purchase card transactions. Refer to SAAM, <a href="https://chapter.40.30">chapter 40.30</a> and <a href="https://cww.ccard.com/cww.c

#### Travel

University employees, students, alumni, volunteers, and board members may incur travel expenses paid by the University. Best practices for employees include:

- 1. Obtaining necessary pre-approvals.
- 2. Using preferred travel agencies.
- 3. Complying with cost limits for meals & lodging.
- 4. Submitting accurate expense reports.

Employees are subject to OFM travel regulations and University policies and procedures. Refer to SAAM, <u>chapter 10</u>, and <u>CWU's Travel</u> Guidelines.

#### **Internal Audit Hotline**

The Hotline is intended for faculty, staff, students and others to report suspected fraud or irregular activities such as improper transactions, suspected thefts, losses, misuse, or inappropriate action involving public funds, equipment, supplies, or other assets. To report a violation, click <u>Hotline</u>.

Key characteristics of the internal audit hotline:

- Online reporting at cwu.edu/internal-audit/hotline
- Discrete and confidential treatment of concerns to the extent possible under applicable laws.
- Employees may provide their names and contact information or may choose to remain anonymous.

Issues you may want to report through the internal audit hotline:

- Fraud/theft
- Conflict of interest
- · Waste and/or misuse of university resources
- Financial policy violations
- Operational policy violations
- Other regulatory violations

Any employee who brings an issue to the university's attention through the Hotline should be aware that university policy prohibits retaliation against employees who in good faith report apparent violations.
